IV. CURRENT RESEARCH ACTIVITIES

- Moving to Work. Analysis of the effects of the Atlanta Housing Authority's Moving to Work Demonstration. This ongoing evaluation focuses on assessing the effects of the MTW Demonstration on AHA-assisted households (public housing, mixed-income housing, project-based rental assistance, housing vouchers), the effects on the neighborhoods affected by public housing transformation over the past 15 years, and the overall trends in poverty deconcentration in the city of Atlanta. The evaluation includes a quasi-experiemental design that compares the trajectories of AHA-assisted families (MTW Demonstration) with families assisted through the Housing Authority of DeKalb County (conventional public housing assistance) via a multiple-wave panel study as well as analysis HUD administrative data that compares outcomes for Atlanta Housing-assisted households to those served by six conventional housing authorities in Fulton and DeKalb counties.
- Making Collaboration Work: Local Strategies to Reduce Poverty and Increase Opportunity. Book manuscript in preparation with Robert Stoker. Our primary argument is that collaborative governance provides a strategic approach for cities to weave together existing and emergent cross-sector collaborations and partnerships to more effectively foster a range of coordinated public policy solutions that provide increased opportunities for city residents (e.g., linking housing and community development, education, job creation/economic development, job training, and transportation, among others). We present empirical evidence through in-depth case studies, city vignettes, and a more systematic assessment of the breadth and depth of collaborative governance in the nation's 50 largest cities.
- Workforce Systems and Economic Mobility in the Greater Atlanta Area. Analysis of the ecology of workforce development systems in the greater Atlanta area using a race, equity, and inclusion lens to examine how, if at all, disparities pertaining to race, ethnicity, gender, and geography are narrowed or widened as low-income job seekers and incumbent workers access the workforce development system. This longitudinal, quasi-administrative research design examines changes in race, equity, and inclusion outcomes during the six-year period 2016-2021.
- Implementation of the Affordable Care Act. With Daniel Lanford. Fifty-state comparative analysis of the configuration of ACA implementation regimes (e.g., type of health exchange, Medicaid expansion, regulatory reforms, consumer outreach and assistance, community health center expansion, etc.) and their determinants as well as the effects implementation regimes have on the ACA's three overarching goals for the nation's health care system—increase accessibility, improve quality, and lower costs.

The Providence Plan, Inc., is a 501(c)3 nonprofit corporation created in 1992 by the city of Providence and the State of Rhode Island to direct the revitalization of Providence. The organization is jointly funded by the city and the state, and governed by a board of directors of 10 members, five of whom were appointed by the mayor and five by the governor. The Providence Plan is a partnership among the city, the state, and a consortium of area colleges and universities dedicated to developing and implementing a comprehensive strategy for alleviating poverty in the capital city of Providence. Its six principal goals are: (1) promotion of affordable housing, (2) improving the quality of the public schools; (3) increasing employment opportunities for city residents; (4) enhancing neighborhood safety; (5) revitalizing the downtown; and (6) retaining the middle class. The Providence Plan has pursued its mission through the development of a comprehensive Geographic Information System and a community-based strategic planning model which culminated in the submission in June 1994 of Providence's application to the federal government for designation as an Enterprise Community under the Clinton Administration's Empowerment Zones and Enterprise Communities program. In December 1994, Providence was designated as one of 60 federal Enterprise Communities.
